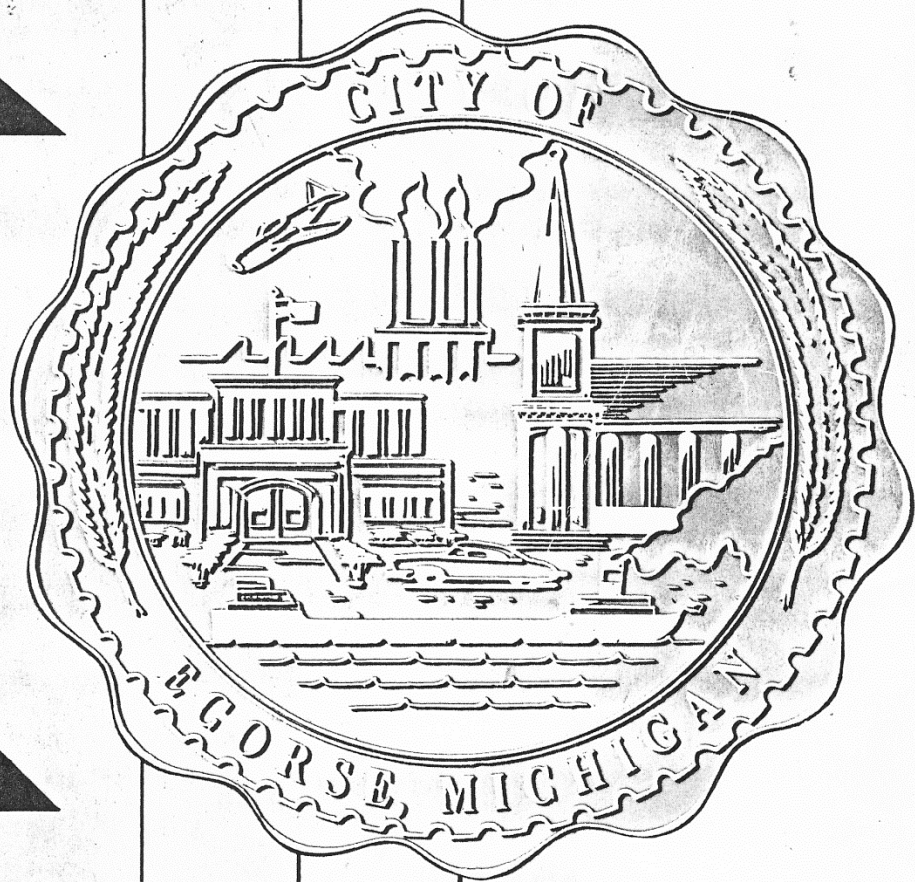
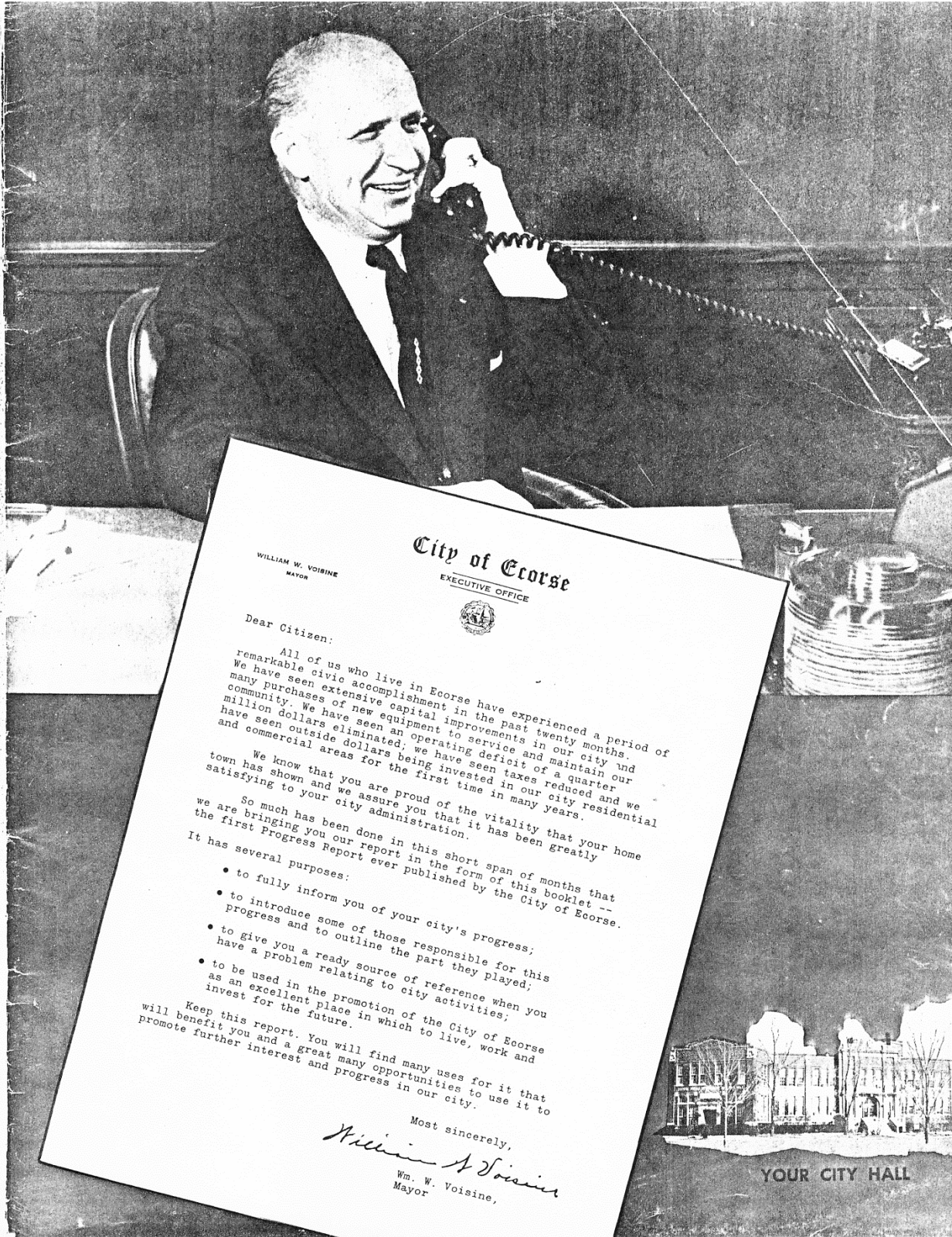

We know that you are proud of the vitality that your home town has shown and we assure you that it has been greatly satisfying to your city administration.

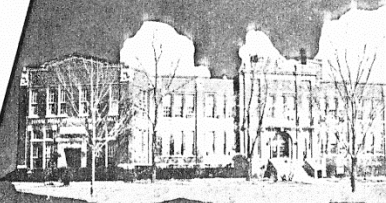
So much has been done in this short span of months that we are bringing you our report in the form of this booklet -- the first Progress Report ever published by the City of Ecorse. It has several purposes:

Keep this report. You will find many uses for it that will benefit you and a great many opportunities to use it to promote further interest and progress in our city.

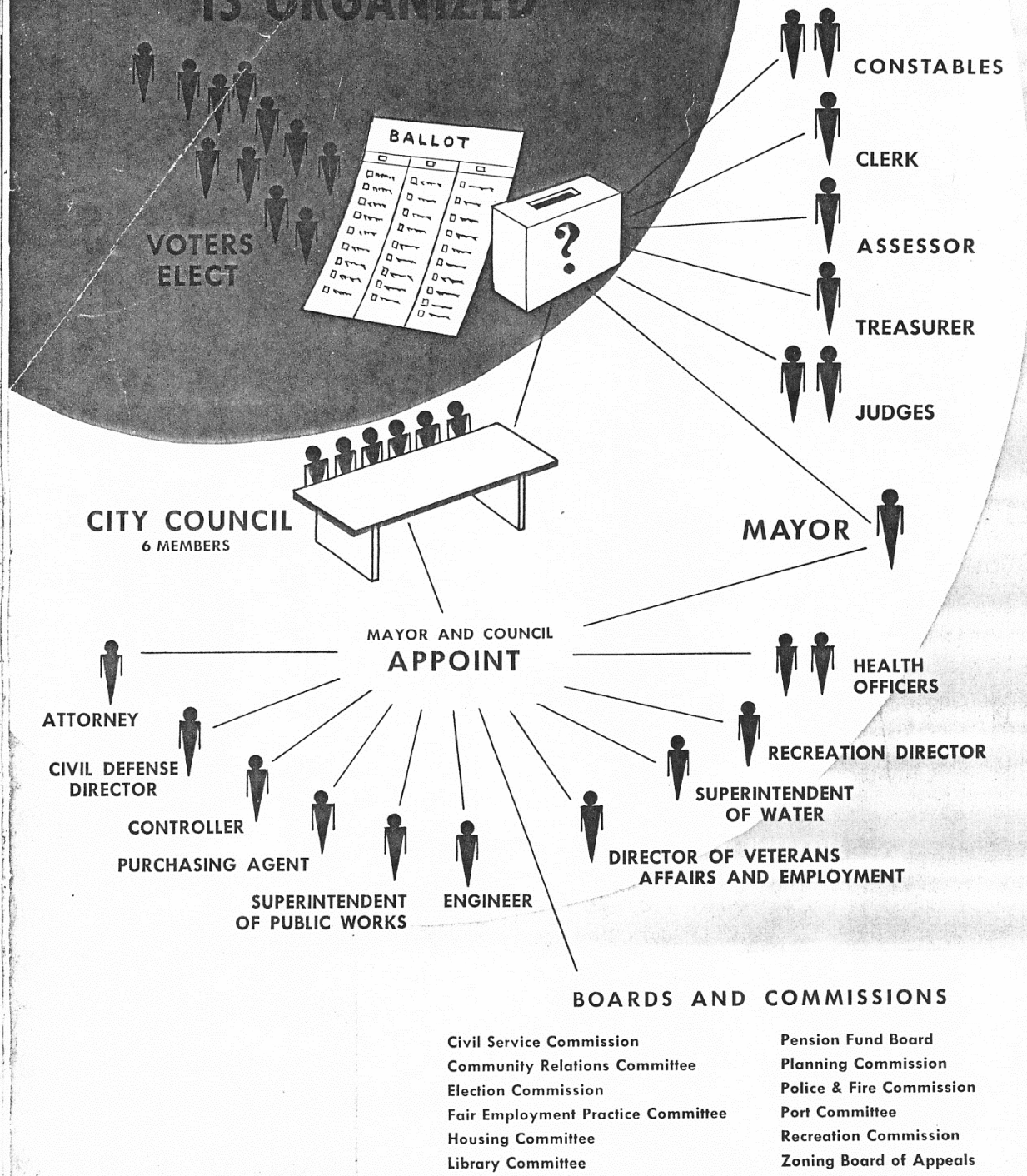

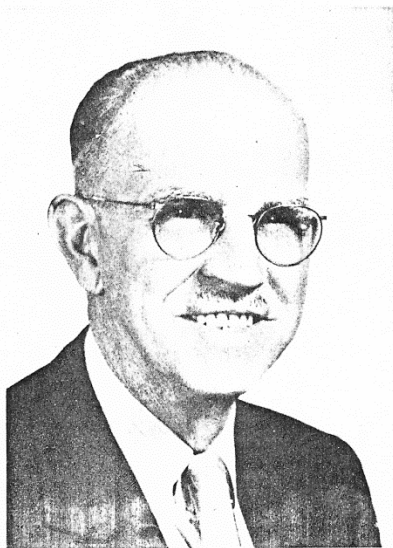


**PATRICK B. TRONDLE**

The City Clerk is the clerk of the City Council. He attends all Council meetings and keeps a record of proceedings and all ordinances, resolutions and regulations passed. He is custodian of the city seal and of the city's papers, documents and records. He gives, to the proper department or official, notice of the expiration of any franchises, contracts or agreements.

In addition, he is the Registrar of Births and Deaths, and he issues city licenses, such as dog licenses and licenses for food establishments, restaurants and taxicabs. He is also the Secretary of the Civil Service Commission and Chairman of the Election Commission. He maintains the election records and conducts elections.

The City Treasurer, assisted by the Deputy Treasurer, has the custody of all money belonging to the city government. He collects taxes, assessments, charges for water service and other charges payable to the city. He also collects state, county and school taxes on the December tax roll. The City Assessor makes a personal assessment at least once a year of Ecorse's industrial, manufacturing, mercantile and residential land and buildings. He assists the Treasurer in the collection of taxes and attends meetings of the Board of Review, of which he is chairman.



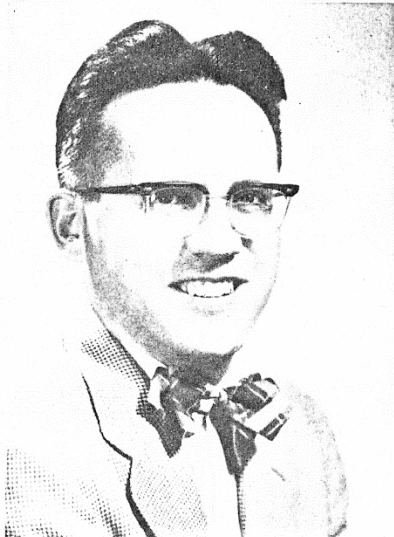

## ATTORNEY

The City Attorney is the legal advisor and attorney for the city, representing it in court cases whenever necessary. He prepares or officially passes upon contracts and bonds in which the city is concerned and keeps copies of its franchises, contracts and agreements.



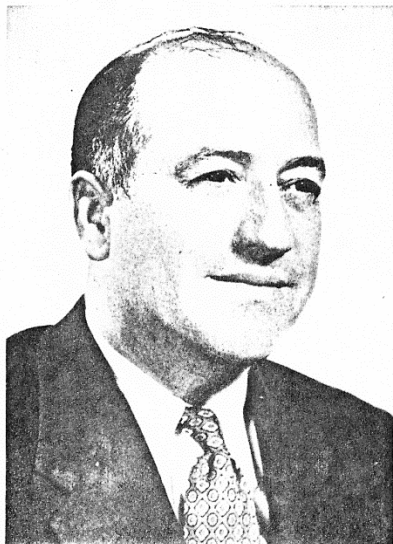

The City Controller receives and audits the accounts against the city. Upon the approval of the City Council, he makes out checks to pay these accounts. He keeps the books and accounts of the city government and a record of the bonds it issues. He maintains a list of the city's property and exercises general supervision over its financial concerns. He also maintains the "Fireman's and Policeman's Pension List." The present Controller is also Administrative Assistant to the Mayor, Personnel Technician of the Civil Service Commission, and Housing Co-ordinator.

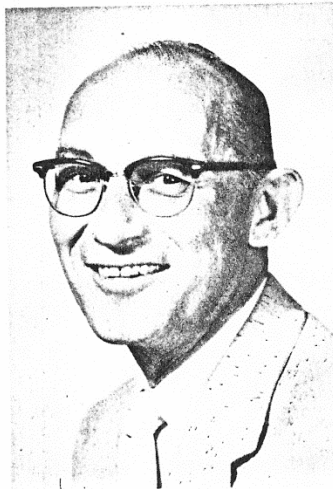

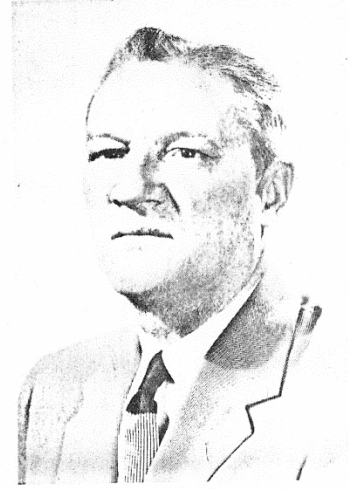

Two judges hear cases that arise under the Charter and Ordinances of Ecorse. These cases include traffic violations, disorderly conduct, assault and battery and non-support. In addition, the Court hears misdemeanor cases that arise in Ecorse for violation of state laws, and felonies, in which the defendant may be bound over to the Circuit Court for trial.

Ecorse's two constables are elected for terms of four years each. They serve summonses and garnishments, carry out evictions and replevins, and are authorized to collect on judgments when an execution is issued by the court. They may arrest for traffic violations.

The Department of Civil Defense is charged with aiding city officials in case of enemy attack. An Auxiliary Police Unit is being trained in police duties; a First Aid Program and a training program for wardens are in operation; and a fire-fighting group is in the process of being formed. A rescue and service squad will also be organized.

The Office of Veterans Affairs and Employment assists Ecorse residents in the securing of employment, provides legal counsel and services complaints and inquiries concerning city functions. In addition, it helps veterans with their official and legal problems.

Ecorse retains a firm of public accountants, Raymond C. Moore & Associates, to examine and audit once a year books of account kept by Boards and Departments. Books kept by the City Treasurer, City Clerk and City Controller are audited at least once each quarter. This firm also helps in preparing the annual budget and presents an annual report which is published in the official newspaper.

## WATER COMMISSIONER

The Water Commissioner prepares and mails bills for water service and sewage disposal, using rates set by the City Council, and remits the amount collected to the City Treasurer. The City of Ecorse purchases its water—over a billion and a quarter gallons a year—from the City of Detroit at the rate of 16¢ per thousand gallons.

The Recreation Director is appointed by the Mayor and Council and is under the supervision of the Recreation Commission. He has direct charge of the recreation program and, together with the Recreation Commission, selects the necessary personnel to staff the playgrounds and recreation centers. He holds this position during the summer months only; for the remainder of the year, the recreation program is supervised by the Board of Education.

The Superintendent of Public Works, on recommendation of the City Engineer, is appointed by the Mayor and Council. He has direct supervision over all men working in the Department of Public Works. It is his duty to assign men to the work to be done each day — rubbish and garbage collection, street cleaning, tree trimming, sidewalk repairs, alley and street grading, supplying rubbish barrels, and other work.

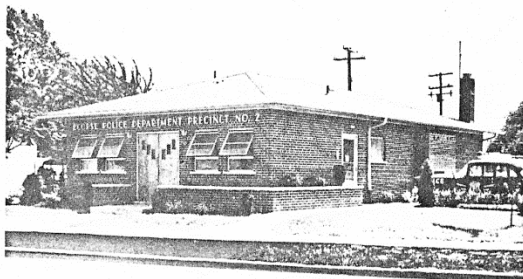

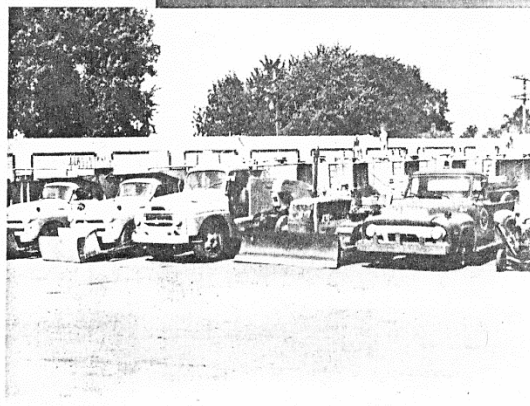

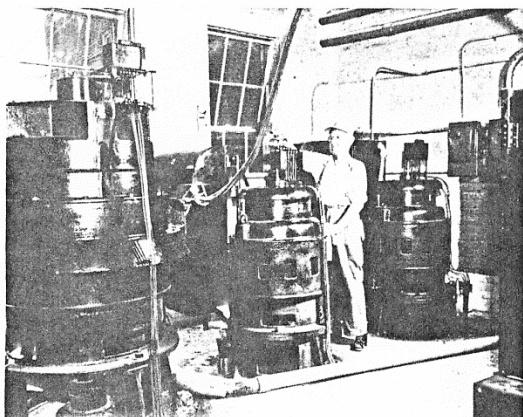

## 4-Year Plan

It is the hope and ambition of Mayor Voisine and the City Council to bring about the fulfillment of a 4-year plan which will expand the facilities and services available to the citizens of Ecorse. Among the objectives of this plan are the following:

- New homes to replace sub-standard housing
- New improved lighting system
- Paving or black-topping of all streets and alleys
- Artificial ice skating rinks
- Auxiliary city garage
- New community centers
- Off-street parking facilities
- Tennis courts and shuffleboard courts
- New pumping facilities

# YOUR TAX DOLLAR

Of every dollar Ecorse citizens pay in taxes, just 42½ cents go for operation of the city. The remaining 57½ cents go for school and county taxes which are payable in December. The school and county tax rates are set by your county government and are not regulated by Ecorse officials in any way.

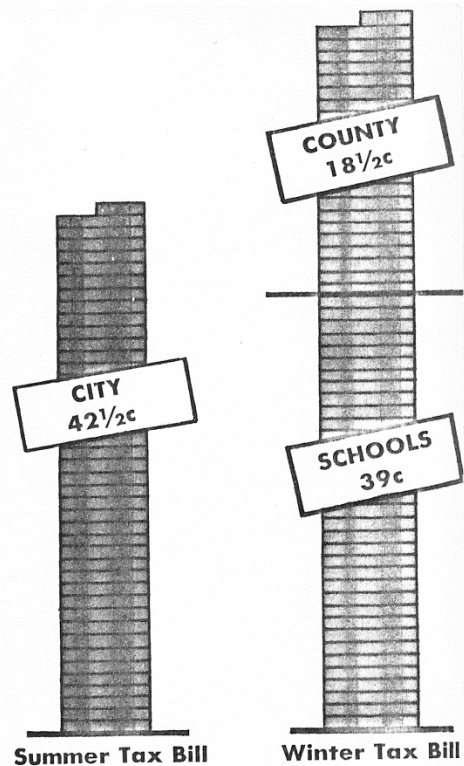

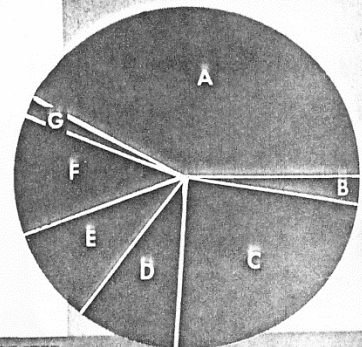

## YOUR GOVERNING OFFICIALS

The Mayor is the Chief Executive Officer of Ecorse. He is a member of the City Council and presides at its meetings. He sees that the laws relating to the city and the ordinances and regulations of the Council are enforced.

The Charter provides for a City Council of seven members—six councilmen and the Mayor. The City Council passes the laws and ordinances of the city. Regular Council meetings are held every other Tuesday. These meetings are public, and any citizen may have access to their minutes and records. In addition, the Council audits and allows the accounts chargeable against the city and has authority to adjust and settle accounts and claims against it. The City Council also appoints the necessary administrative officials and creates new departments when required. It levies and collects the tax funds necessary to operate the city government.

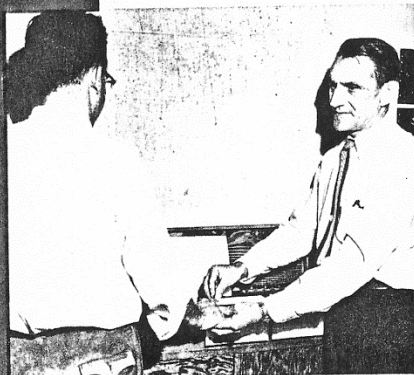

Your Police Department received and acted upon almost 6,000 complaints during 1954, ranging from "Autos Stolen" to "Vagrancy." 4,261 traffic tickets were issued, and \$72,472.79 worth of stolen property was recovered.

Eleven radio cars are in operation on the city streets, five of them bearing a distinctive marking scheme used only by Ecorse. Nearly fifty cars and 100 policemen can be called from nearby communities into emergency action within a few minutes. Radio contact is also maintained with fourteen other police departments and the Michigan State Police.

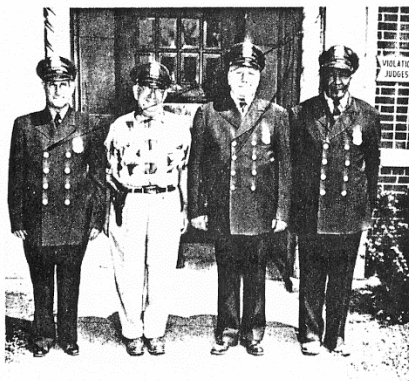

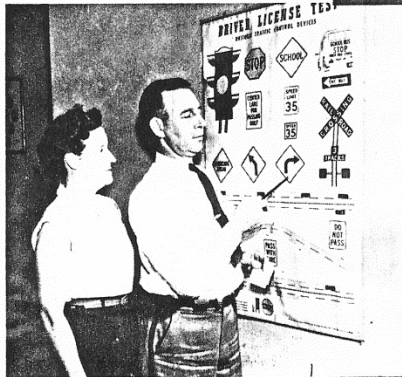

## FIRE DEPARTMENT

Ecorse has one of the finest fire departments of any city of its size. Two fire stations—No. 1 at the Municipal Bldg., 4373 High St., and No. 2 at 27113 Outer Drive—are manned by a total of 32 officers and men.

Two radio-equipped American-LaFrance 1,000 gallon pumpers are on 24-hour duty, with a slightly older pumper of the same capacity maintained on a standby basis. In addition, the Fire Department maintains a Chief's car, a Fire Inspector's car and a fully-equipped ambulance, which is operated in conjunction with the Police Department. The two engines and the ambulance are equipped with resuscitators for reviving persons overcome by gas or drowning.

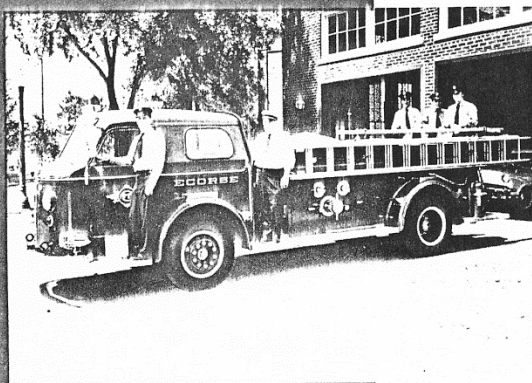

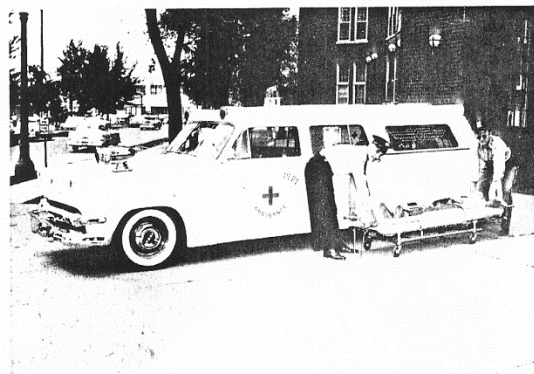

Fire Station No. 1's pumper

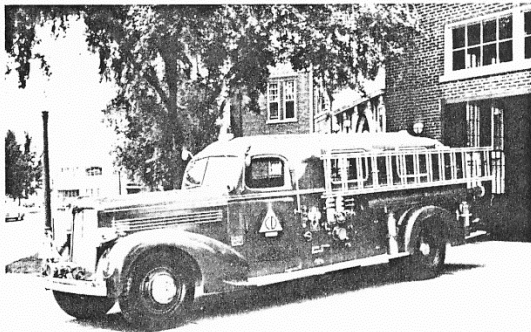

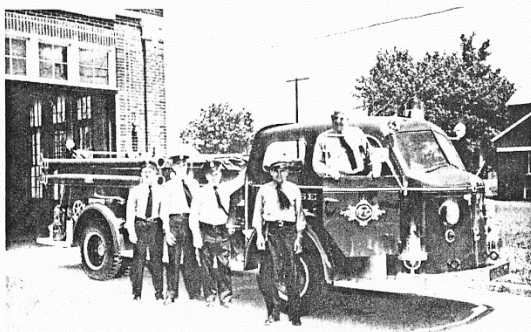

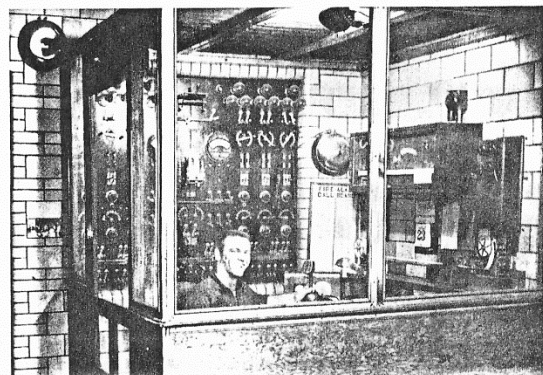

# *Department of* **PUBLIC WORKS**

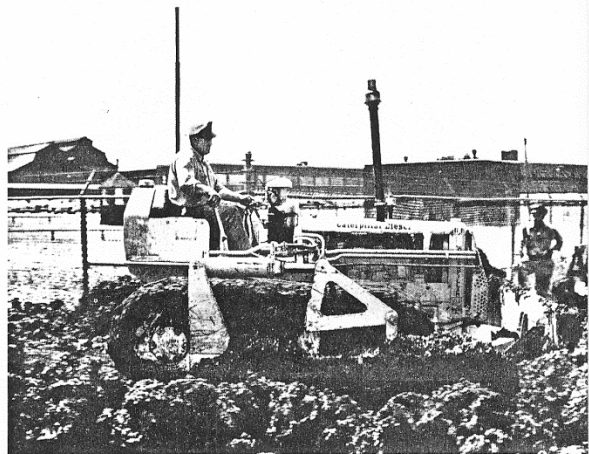

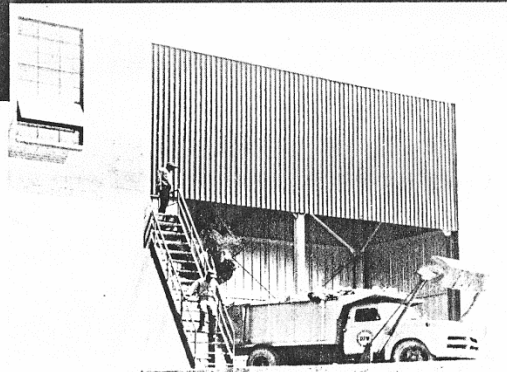

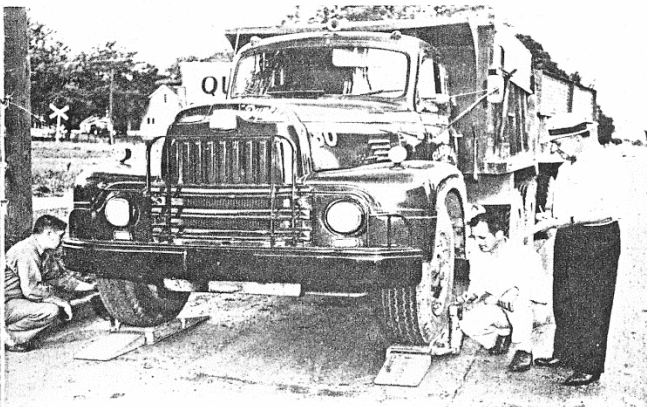

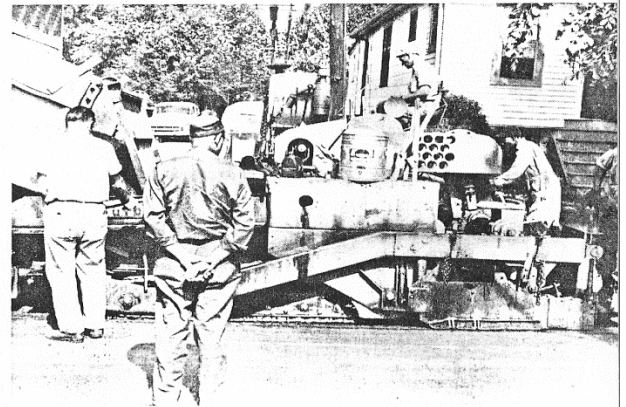

# Department of **RECREATION**

The program of the city's Recreation Department is closely coordinated with that of the Recreation Department of the Board of Education. The major emphasis of the city program is on the summer months when the school program is not functioning.

Summer recreational activities emphasize outdoor group participation for children, youth and adults. Facilities include three baseball fields, five softball fields, three wading pools, one swimming pool, six playgrounds, six play areas for little children, six tennis courts and four gymnasiums.

The winter recreational program has utilized the four school gymnasiums, the West Side Community Center and the Ecorse High School Industrial Art Section. Six ice skating rinks are maintained.

Two teen-age clubs composed of junior and senior high school students sponsor supervised parties and other recreational activities. Activities for younger children include chaperoned trips to the Detroit Zoo, Greenfield Village, Affholter's Dairy, Grosse Ile Naval Base, Rouge Park, The Detroit News and radio and TV station WWJ. The children also participate in circuses, doll and pet shows, talent shows, picnics and competitive races on Ecorse Day (July 4th).

It is the aim of the Ecorse Recreation Department, in cooperation with the Ecorse Board of Education, to provide a wholesome, properly directed vocational and recreational program for the various age groups in the city. Programs are planned which develop character traits in those who participate, tending to make them better, happier, healthier citizens.

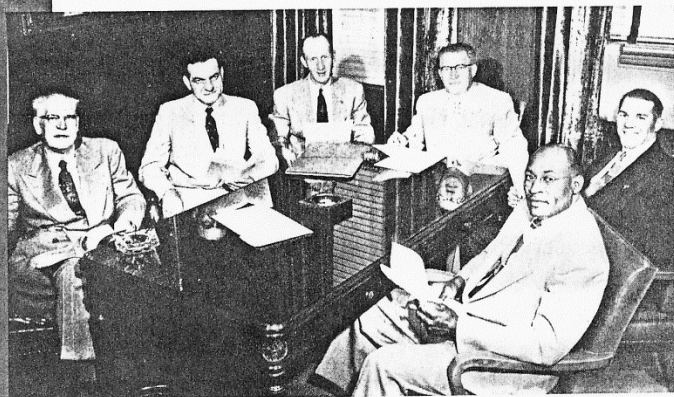

## POLICE and FIRE COMMISSION

The Police and Fire Commission consists of five members appointed by the Mayor and confirmed by the Council for a term of five years. One member's term expires each November. The Commission has general control and management of the Police Department and Fire Department and appoints the personnel of these departments. Members are William LaJoie (retired), Patrick Slitti, Harry Monks, Jr., Nick Stroia, William Montry and Greelie Dukes.



## CIVIL SERVICE COMMISSION

The three members of the Civil Service Commission are appointed for a six-year term—one by the Mayor, one by the City Council, and the third by the two previously selected. Assisting them are a personnel technician and a secretary. This Commission represents the public interest in the improvement of personnel administration in the city government, establishing policies and practices governing all phases of civil service. Members are William W. Jones, Bruce A. McNeillage, James R. Campbell, Charles Steffes and Patrick B. Trondle.



## PENSION FUND BOARD

The Pension Fund Board consists of three members—one appointed by the Mayor, one elected by the firemen, and one elected by the policemen—whose job it is to investigate and recommend the investment of money in the Pension Fund and to supervise the expenditure of money from this fund. Members are Lewis J. Nagy, Jr., Rocco J. Sanfilippo and Conrad C. Swearingen.





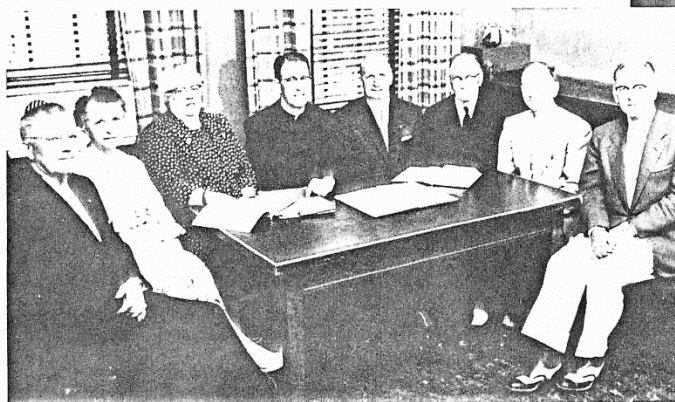
## PLANNING COMMISSION

The Planning Commission has the responsibility for changes and improvements in the master plan of Ecorse; recommending changes in zoning; location of buildings, streets, viaducts and waterways; along with replanning and redeveloping blighted districts and slum areas, all with the general purpose of guiding and accomplishing a coordinated and harmonious development of the city. Members are Bud Osborn, Rocco Sanfilippo, Charles Coman, Charles Grayson, Isaac Murrow and Charles McMurdo (absent). Ex-officio members are Mayor Voisine, Councilman Hickey and City Attorney Mitea.



## ZONING BOARD of APPEALS

The Zoning Board of Appeals hears and decides appeals from any order or decision made by an administrative official charged with enforcement of city ordinances. They hear and decide appeals relative to zoning ordinances, building restrictions, streets, alleys and other matters pertaining to the public health, safety and general welfare of the people of Ecorse. Members are Dominic Michael, George Richards, Stanley Golus, Luther Carrington and George Seleske.



## LIBRARY BOARD

The Library Board supervises the library quarters, purchases books and supplies, and appoints library personnel. Members are Elmer G. Korn, Mae Moore, Josephine Fluharty, Fr. William J. Carolin, Mayor Voisine, Rev. Leonard Duckett, Walter H. Kaiser (county librarian) and Ralph E. Brant.

The Engineering Staff carries out the duties of the Department of Engineering and Building. They issue building and other permits, make inspections and assist with city construction problems. ## HEALTH DEPARTMENT

Located on the second floor of the Engineering Bldg. at 50 Cicotte St., the Ecorse Health Department is staffed by registered nurses Helen Caffo and Beulah Hill. The health and welfare of Ecorse residents is safeguarded by controlling communicable diseases, investigating complaints pertaining to health problems and making home visits for maternal and child health care.

Two Well-Baby Clinics are maintained to provide periodic examination by a physician, diet advice and immunization against whooping cough, diphtheria and small pox.

This fall, as a voluntary community project, Mrs. Caffo plans to organize Red Cross classes in home nursing.

The Ecorse Chest Clinic, under the supervision of the Wayne County Department of Health, is under the direction of Dr. James F. Busby. Services of the clinic include diagnosis of chest conditions, detection of cases of tuberculosis, routine chest x-rays of persons who have been in contact with tuberculosis, tuberculin tests when indicated and yearly routine chest x-rays. Anyone may have a free chest x-ray at the clinic.

### PORT COMMITTEE

### FAIR EMPLOYMENT PRACTICE COMMISSION

Enforcement of the Fair Employment Practice ordinance rests with this commission. The ordinance makes it unlawful for employers to discriminate in hiring of workers because of race, color, creed, national origin or ancestry. ### ELECTION COMMISSION

The Election Commission consists of the City Clerk, the City Attorney, the City Treasurer and two additional members appointed by the City Council. ### COMMUNITY RELATIONS COMMISSION

The Community Relations Commission was established for the purpose of bringing about better understanding and relationships among all groups of people in Ecorse, regardless of race, color or creed. It is the hope of the commission that a trained full-time director may be employed jointly by Ecorse and River Rouge to help solve any mutual problems that may arise. Members are Rev. 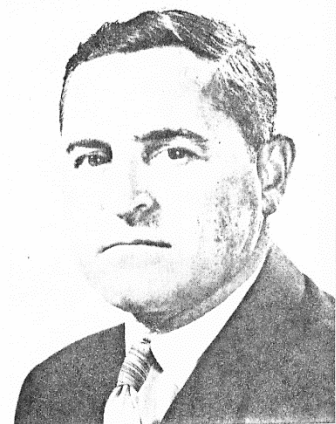

Members of the firm of Mason L. Brown & Son, consulting engineers, have charge of the Department of Engineering and Building. They make all necessary plats, maps, surveys, diagrams and estimates, and plans and specifications; issue permits required by the building code and zoning ordinance; manage the Department of Public Works; and supervise the construction and installation of elevators, steam and hot water boilers, oil and gas burning furnaces, smoke stacks, pressure tanks and any form of apparatus dangerous to life and property.

## HOUSING

During World War II, the Federal Government leased areas from Ecorse property owners to provide temporary, low-cost housing for war workers.

The City Government took over the management of Grand Port Homes in October, 1954, and the management of about half of Hyacinth Court in November, 1954, with the Federal Government retaining management of the other half.

Your City Government has spent thousands of dollars to save these housing projects from being completely torn down by the Federal Government. It is working constantly with private builders to provide new homes, with no down payment required, to residents of the housing areas.

It has been a discouraging and exasperating task, but it is hoped that within the next two years both areas will be re-developed with beautiful new homes which will contribute to making Ecorse a more desirable community in which to live.

Your City Administration asks your cooperation and understanding as it proceeds with the task of relocating families and re-developing your community.

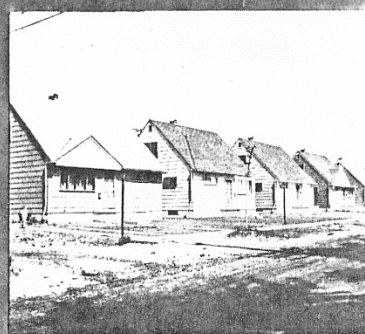

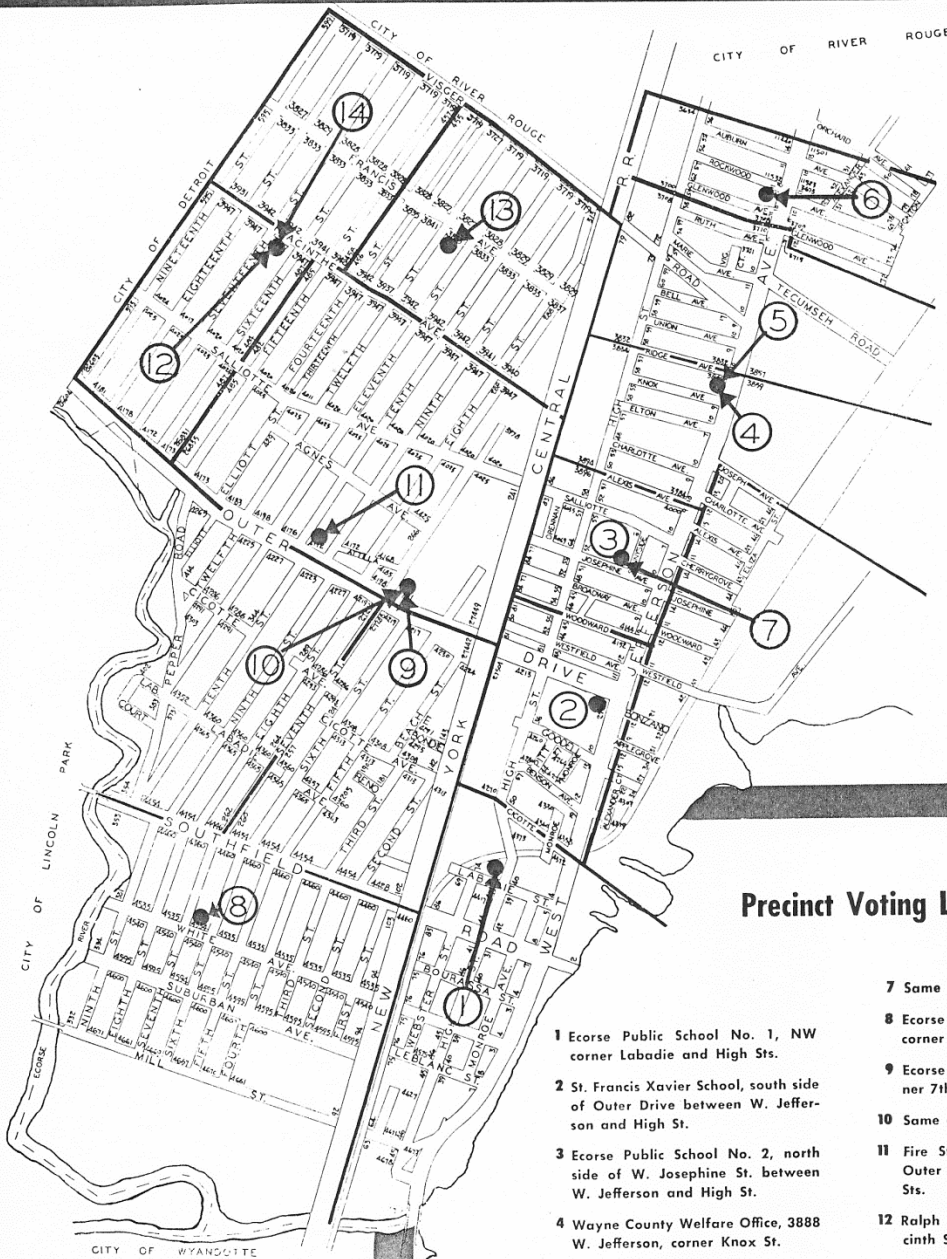

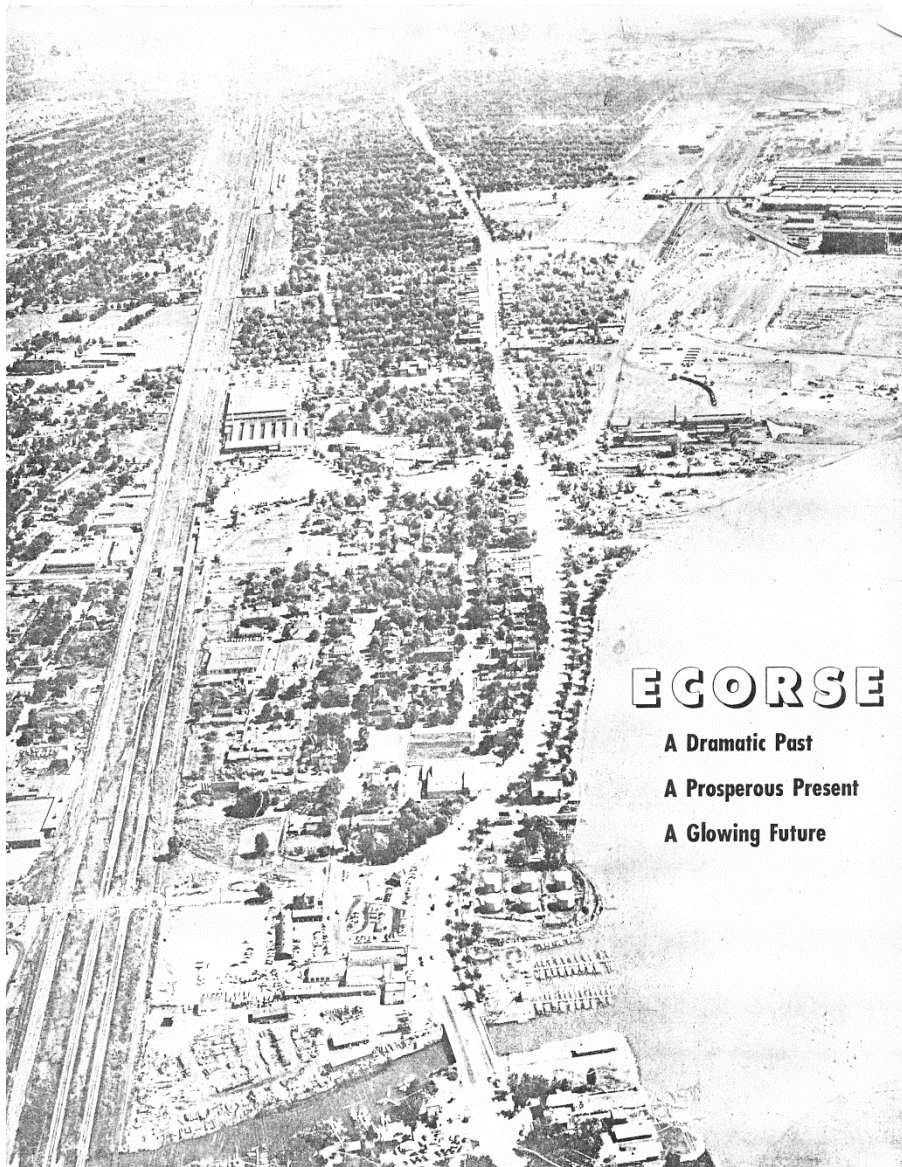
